PRE-APPLICATION DOCUMENT**

On July 27, 2010, Juneau Hydropower Inc. (JHI) filed documents with the Federal Energy Regulatory Commission (FERC) in Washington DC regarding a proposed hydroelectric project within the boundaries of the City and Borough of Juneau, Alaska. The Project and its respective bodies of water are the Sweetheart Lake Hydroelectric Project and its surrounding environs. Generating facilities and transmission lines are intended to generate power in Alaska for sale within the City and Borough of Juneau and surrounding locations as more fully described in the filed documents.

The documents filed were: 1) Notice of Intent (NOI) to seek federal license; 2) Pre-Application Document (PAD) describing the project, the proposed location and design and potentially-affected environmental resources, and 3) a request to use the Alternative Licensing Procedures (ALP). The ALP is a process under which applicants for FERC license of hydroelectric projects work collaboratively with the public, state, and federal resource agencies, affected Tribes, and NGO's (collectively "Stakeholders") to reach agreements on construction and operation conditions for the project. JHI believes that the ALP as set forth in 18 CFR 4.34 (i) is the appropriate licensing process for the Sweetheart Lake Hydroelectric Project.



FERC strongly encourages e-filing. Please reference the project name and P-13563, the docket number of the project, when submitting comments.

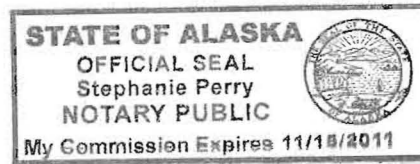
